The purpose of this notice is to provide Noteholders with an update on the status of the Notes and the underlying Secured Term Loan Agreement.

BACKGROUND

The Issuer previously sent out a notice to Noteholders on 14 July 2022 (appended as Annex A hereto) informing Noteholders that the Borrower had failed to make an interest payment under the Secured Term Loan Agreement on 30 June 2022 (the “**Missed Interest Payment**”).

As of the date of this notice the Borrower has made the Missed Interest Payment in full together with interest accrued on such Missed Interest Payment at the default rate.

NEXT STEPS

The Issuer will make a payment of interest to Noteholders as specified in the Conditions of the Notes.

PROPOSED ACTION

This notice is for informational purposes only and Noteholders are not required to take any action at this time.
